



Dear Prospective Wings of Carolina Flying Club Member:

Congratulations on your decision to join the Wings of Carolina Flying Club! We are excited to have you as a new member. Our goal is to make it as safe, fun, and affordable as possible for you to meet your aviation goals.

Here is what you need to do to join:

1. Fill out the Pilot Membership Application form as applicable for you as a new, student, or licensed pilot.
2. Carefully read the page titled **IMPORTANT INFORMATION FOR PROSPECTIVE MEMBERS**.
3. Fill out NC DMV form DL-DPPA-2. This form authorizes the DMV to release information about your driving record to the Club. The information is essential to our risk management process for insurance purposes. All information released to the Club will be kept confidential.
4. Mail the NCDMV form and a check for \$8.00 payable to **NCDMV** to the address listed on the DMV form. If you picked up your application from the Club, there should be pre-addressed envelope included with it.
5. If you have had a NC driver's license for less than three years, you must arrange for your driving record from the previous state to be sent to the WCFC Vice President. You can find information on how to do that by using the Division of Motor Vehicle's website for your state.
6. Attach to the application page a check made out to the Wings of Carolina Flying Club. The check amount varies by the type of aircraft you intend to fly. Use the following information to determine how much to pay:
 - a. Application Fee - \$200.00 - Full Member & Member; \$25 – Associate Member
 - b. First month's Dues - \$60.00 – Full Member; \$15 – Member; \$20 – Associate Member
(your account will be credited for each day past the first of the month)
 - c. Aircraft Deposit required by Full Member and Member levels (provides capital for the Club: generally refundable within 30-40 days after resignation from the club, but theoretically could require liquidation of assets to repay)

IMPORTANT INFORMATION FOR PROSPECTIVE MEMBERS
(PLEASE READ BEFORE SUBMITTING APPLICATION)

Responsibilities of Club Membership

The Wings of Carolina Flying Club is an organization created to provide aeronautical education and experience at the most reasonable cost. Membership is open to any interested individual who demonstrates an attitude of safety consciousness, courtesy and service to the Club and community, and agrees to abide by the Club's Bylaws and Standard Operating Procedures. Please note that Club SOPs are frequently more rigorous than FAR requirements (e.g. with regard to fuel minimums), and compliance with SOPs is mandatory.

The Club is organized so that all members are co-owners of the Club aircraft, and with that ownership comes significant responsibility. In order to maintain a rate structure compatible with affordable aeronautical experience, the Club depends primarily on volunteer efforts for most routine activities. These activities include service projects such as participating in 50 hour maintenance on the aircraft, maintaining the Club Operations building and grounds, and regular cleaning (washing, waxing and vacuuming) of aircraft. Volunteer effort is expected from all members.

Membership Applicant Screening Procedure: Driver's License Record Check

It is the policy of the Wings of Carolina Flying Club to review an applicant's motor vehicle record for the seven year period prior to application. In general this process for an applicant with a NC driver's license for at least seven years will take about two weeks. For an applicant with a current out of state license or a relatively recent NC driver's license, where another state must be contacted, the process may take 6-8 weeks. For an applicant with a driver's license from another country, it is YOUR RESPONSIBILITY to provide an English language copy of your driving record. Failure to do so may result in disapproval of your application.

While the license review is pending, new student pilot members may begin dual flight training with an instructor. New licensed pilot members may begin their check-out in the type of Club aircraft that they plan to fly. However, a new member applicant may not solo a club aircraft until their application is approved.

While the Board may exercise flexibility in dealing with a particular applicant (especially with regard to demonstrated attitude) the following guidelines will otherwise be observed.

1. No Board review is necessary and **application approved** if:
 - a. There are no DWI convictions on the record, and;
 - b. There is no more than one speeding or moving violation within 24 months, or two speeding or moving violations within the past seven years.

2. Board review and **extension of probation** to 12 months (and Board review at that time) and all references checked, if:
 - a. There is one DWI conviction at least 24 months prior to application, or;
 - b. There are two speeding convictions or other moving violations within the past 24 months, or;
 - c. There are three speeding convictions or other violations within the past seven years, and;
 - d. The total number of convictions or license suspensions within seven years does not exceed three.

3. Board review and **rejection of application** for membership, if:
 - a. There are two or more DWI convictions within the past seven years, or;
 - b. There are three speeding convictions or other moving violations within the past 24 months, or;
 - c. There are four or more speeding convictions or other moving violations or license violations within the past seven years.
